

ENVIRONMENT CANTERBURY NAVIGATION SAFETY BYLAWS 2011

Amendment 1 to Environment Canterbury Navigation Safety Bylaws 2010

The Canterbury Regional Council (Environment Canterbury) is proposing to amend the Environment Canterbury Navigation Safety Bylaws 2010, in accordance with the Special Consultative procedure set out in s83 of the Local Government Act 2002.

The purpose of the amendment is to amend the bylaws for the Dobson, Godley, Hopkins and Macaulay Rivers. Under proposed Amendment 1, boat speeds exceeding 5 knots on these rivers will be permitted between 25 December to 30 April in the following year; while from 1 May to 24 December (in any year) a 5 knot speed limit will apply on these rivers.

Any person interested in the Bylaw review may make a submission. Submissions must be received by **5.00pm on Tuesday 1 November 2011**.
