PUBLIC NOTICE

PROPOSED HURUNUI AND WAIAU RIVER REGIONAL PLAN

Pursuant to Clause 5 of the First Schedule of the Resource Management Act 1991, the Canterbury Regional Council (Environment Canterbury) gives notice it has prepared the Proposed Hurunui and Waiau River Regional Plan and Plan Change 3 to the Natural Resources Regional Plan (NRRP).

The Proposed Hurunui and Waiau River Regional Plan introduces objectives, policies and rules to manage fresh water resources in the Hurunui, Waiau and Jed River Catchments. It supersedes the surface and groundwater allocation rules in the NRRP and builds on the existing management framework in the NRRP for managing the effects of land use on water quality.

Plan Change 3 to the Natural Resources Regional Plan removes the provisions that relate to surface and groundwater allocation and the existing NRRP rules which control the effect of land use on water quality.

Inspection and availability of the Proposed Hurunui and Waiau River Regional Plan and Plan Change 3 to the Natural Resources Regional Plan.
