SUMMARY OF DECISIONS REQUESTED GUIDELINES

However, if amendments are not apparent, then the direction provided in the submission has been included. Submissions which quote substantial sections of the Plan Change 4 text without amendment, ellipses [...] have been included to indicate the omitted text.

Where the decision requested is unclear, this is stated, and the reader ought to refer to the original submission.
