# Variation 3 – Proposed Canterbury Land & Water Regional Plan

## What is Proposed Variation 3?

Proposed Variation 3 is the third proposed change to the proposed Canterbury Land & Water Regional Plan (pLWRP) related to a specific area - the South Coastal Canterbury Area. It seeks to put in place policies and rules to help achieve the community goals for freshwater management in the South Coastal Canterbury Area that have been developed under the collaborative Canterbury Water Management Strategy.

#### How will Proposed Variation 3 change the pLWRP?

Proposed Variation 3 seeks to replace most of the policies and rules for the South Coastal Canterbury Area in Section 15 – the Waitaki and South Coastal Canterbury sub-regional section of the pLWRP. Proposed Variation 3 also seeks to amend the Canterbury Map Series in the pLWRP Planning Maps as they apply to the South Coastal Canterbury Area.


Proposed Variation 3 describes the limits, targets, timeframes and additional policies and rules to address over-allocation of

water quantity and water quality in the South Coastal Canterbury Area. This means that activities occurring in the South Coastal Canterbury Area will have to comply with the region-wide rules in Section 5, along with the specific sub-regional rules that apply in the South Coastal Canterbury Area as a result of Variation 3. All the rules in Proposed Variation 3 have immediate legal effect under section 86B of the Resource Management Act 1991 from the date of notification of Proposed Variation 3.

## South Coastal Canterbury area

The South Coastal Canterbury Area is situated in the Waimate District in South Canterbury, and spans from the Otaio catchment in the north to the Morven catchment in the south and to the Hunters Hills in the west. The South Coastal Canterbury Area is made up of hill-fed intermittent flowing rivers and lowland streams with the major feature of the area being Wainono Lagoon. The South Coastal Canterbury Area is split into three sub-areas (Northern Streams, Waihao-Wainono and Morven-Sinclairs) to manage water quality. The South Coastal Canterbury Area is shown on the map below.
