**SUBJECT:** Changes to be made to the Canterbury Land and Water Regional Plan

pursuant to Clause 20A of Schedule 1 to the Resource Management Act

1991 (RMA)

## Clause 20A of Schedule 1 to the RMA states:

"A local authority may amend, without using the process in this schedule, an operative policy statement or plan to correct any minor errors"

The following alterations of minor effect are recommended to be made to the Canterbury Land and Water Regional Plan.

Type of Error or Reason for Correction	Minor Correction	Location
Typographical error	Delete the second entry of 'Section 4 – Policies' from the table of contents index.	Page V - Table of Contents index, in-between 'Section 4 Policies' and 'Strategic Policies'.
Typographical error	Remove the word 'Proposed' from the title of the 'Hurunui and Waiau River Regional Plan'.	Page 31 – In the table under the first column titled 'Regional Plan' and 3 instances in the column titled 'details'.
Typographical error	Change capital 'T' to a lower case 't'.	Page 34 – At the definition of 'Community wastewater treatment system'. The word 'treatment' after the word 'wastewater' and before the word 'system' in in the 7 <sup>th</sup> row down in the 'Word' column.
Typographical error	Change capital 'l' to a lowercase 'l'.	Page 35 – At the definition of 'Construction'. The word 'includes' before the word 'all' in the 3 <sup>rd</sup> row down in the 'Definition' column.
Duplication	Delete duplicate entries of 'Group drinking-water supply' and 'Groundwater'.	Page 38 – At the definitions of 'Group drinking-water supply'

		and 'Groundwater'. 7 <sup>th</sup> and 8 <sup>th</sup> rows down.
Typographical error	Renumber the second instance of '2' as '3' and renumber the rest of the list accordingly from '3'-'5' to '4'-'6'.	Page 173 – At Rule 9.5.3 in the matters of discretion.
Missing text	Insert an additional row to the Section 16 Schedules index with 'Schedule 24' in the Number column and 'Farm Practices' in the Title column.	Page 247 – After row 'Schedule 23'.
Typographical error	Change the word 'E coil' to 'E.coli'	Page 271 – In the table headed Groundwater, in the Contaminant column
Typographical error	Renumber the second instance of '2' as a '3' and renumber the rest of the list accordingly from '3'-'4' to '4'-'5'.	Page 203-B – At Rule 11.5.50 in the conditions of the rule.

It is considered appropriate to use Clause 20A to Schedule 1 to the RMA to amend the Canterbury Land and Water Regional Plan for the following reasons:

- These alterations have been recommended to address typographical or grammatical errors in the Canterbury Land and Water Regional Plan, and the alterations do not materially alter the substance, intent or application of these provisions;
- The proposed alterations are of neutral effect and does not prejudice the rights of any person that made a submission on these provisions.

The above changes as recommended by Environment Canterbury staff, are approved as changes of minor effect under Clause 20A, and a copy of these changes is displayed on the Environment Canterbury Website.
