Public Notice of Proposed Plan Change 1 to the Waitaki Catchment Water Allocation Regional Plan

Pursuant to Clause 5 and Clause 26 of the First Schedule of the Resource Management Act 1991, the Canterbury Regional Council (Environment Canterbury) gives public notice of proposed Plan Change 1 to the Waitaki Catchment Water Allocation Regional Plan ("proposed Plan Change 1").

The Canterbury Regional Council (Environment Canterbury) has accepted the request by Meridian Energy Limited for the following proposed plan change to the Waitaki Catchment Water Allocation Regional Plan (WCWARP).

Proposed Plan Change 1 seeks to amend the WCWARP to allow Lake Pukaki to be managed for emergency electricity supply for New Zealand or the South Island by permitting the Lake to be operated between the levels of 513 m (amsl) and 518 m (amsl) during times of independently determined electricity shortage. To achieve this, proposed Plan Change 1 includes amendments to Policy 36 and Rules 3 and 17 of the WCWARP.

The process for public participation in the consideration of proposed Plan Change 1 under the RMA is as follows:

After the closing of submissions, Environment Canterbury will publicly notify the availability of a summary of all decisions requested in submissions, and will allow a period for further submissions in support of, or in opposition to, those submissions already made. Only the following persons may make a further submission:

- any person representing a relevant aspect of the public interest;
- any person that has an interest in proposed Plan Change 1 to the WCWARP greater than the interest that the general public has; and
- the local authority itself.

If a person making a submission asks to be heard in support of his or her submission, a hearing must be held

Environment Canterbury must give its decision on the provisions and matters raised in the submissions (including its reasons for accepting or rejecting submissions) and give public notice of its decision within 2 years of notifying the proposal and serve it on every person who made a submission at the same time.
