Publication of notice of Reservation: Notice of this Temporary Reservation shall be made public by way of appropriate websites (in particular the Coast to Coast website) signage and media, Christchurch Star and Press and directly to representatives of known affected user groups, during the week preceding the event as a minimum.

Notices of this Temporary Reservation shall be displayed where they may best be seen by river users at the following locations from Thursday 1st February 2018, and removed the day following the event: At the Mt White Bridge kayak put-in; Alongside the access road into the Woodstock launching area; At the access route to the river at the Waimakariri Gorge Bridge; At the launching ramp on the Waimakariri River immediately upstream of the SH1 bridges; At any other locations routinely used for launching of powered or non-powered vessels.

#### Part One

Temporary Exemption Certificate (From Maritime Rules Part 91.4(1) and (6)), issued pursuant to: Maritime Rules Part 91.4(5)

Ultimate Event Productions Ltd is hereby temporarily exempted from Maritime Rules Part 91.4(1) and (6) for the river section of the 2020 Coast to Coast race under Maritime Rules Part 91.4(5), thus:

Certificate Holder: Richie Owen, Race Director, Ultimate Event Productions Ltd Period: From 0700 hours until 2100 hours on Saturday 7th February 2020.

Purpose: To allow the use by event competitors and safety kayakers of PFDs that do not comply with Maritime Rules Part 91.4 but are nonetheless assessed by event river scrutineers as being fit-for-purpose. It is intended that this Temporary Exemption is to be applied in cases of exception only (expected to be few, if any) and is not to be used or promulgated as a general rule.

Area to which this Temporary Exemption applies: All that part of the Waimakariri River from 100m upstream of the Mount White Bridge in the Upper Waimakariri River to 100m downstream of the yacht club boat ramp at Stewarts Gully. Exemption: Under Maritime Rules Part 91.4(5) Coast to Coast is exempted from Maritime Rules Part 91.4(1) and (6) subject to the Conditions below:

## Conditions:

PFDs must be worn at all times by all persons on board all vessels taking part in the event. PFDs not complying with Maritime Rules Part 91 may be allowed to be worn by competitors and safety kayakers provided that they are assessed as being in good condition; and provide at least an equivalent standard of safety to that of a fully compliant PFD; and are fit for purpose for the event.

Such assessment shall only be made on the Saturday of the event by the event scrutineers stationed at Mount White Bridge and must be agreed to by a Nominated Assessor as listed below.

Other than cases of exception made under this Temporary Exemption, all PFDs worn on board paddle craft taking part in the event shall be compliant with Maritime Rules Part 91.

A copy of this Certificate shall be carried by the Nominated Assessor who shall have the final say as to whether or not this Temporary Exemption may be applied to any particular PFD.

Those in support and safety vessels are to wear appropriate PFDs at all times, and the vessels are to be appropriately equipped for their safety role.

The Holder of this Temporary Exemption Certificate shall undertake all reasonably practicable precautions to ensure the health and safety of all persons involved in the race.
